There is also a pre-application that has been submitted to SMDC for 13 affordable homes in the middle of the sites under application for solar/battery sites and is a concern that new houses could be approved in isolation to the other applications. Councillor Ahmad stated that if they are eco/affordable houses they can be approved to be built on greenbelt. Councillor Mrs. Lovatt stated we will discuss it when an application is submitted.

7. <u>UPDATE SMDC/GREENBELT PUBLIC MEETING RE. SOLAR PANELS/BATTERY</u> STORAGE APPLICATIONS - Councillor Mrs. Lovatt attended the meeting on 6<sup>th</sup> June 2024 and that since there has been a further battery storage application submitted to SMDC which falls within Bagnall Parish. It was well attended by the public and Bagnall Parish Council and Rt. Hon. Dame Karen Bradley MP. Information gained was that it has been noted in parliament that the cumulative effect of these applications and testing of the grade of soil and consideration of impact on residents and community. A further explosion has occurred in another battery storage facility, and these cannot be controlled with water when they are on fire. Some approved have no fire risk assessment. Which is interesting that one of the applications currently submitted is for two water 76,000 litres, storage units as part of the application. It is having an impact on residents' mental health as concerns on the impact on them and the devaluation of the properties that they own. It is the battery storage that is the most concerning. Safeguarding is paramount. All neighbours should receive notification of applications. The Clerk reported that Urban Vision have submitted a quote to help with submissions and we need to join together with all the Parishes affected. This can be put forward at the Staffs Moorlands Parish Assembly Meeting this week.

Councillor Pointon re-joined the meeting.

8. <u>SMDC PLANNING ENFORCEMENT REPORT - STATION ROAD & WALL LANE</u>
<u>TERRACE, CHEDDLETON</u> - The Clerk reported that Enforcement have reported back for further information about the business on Station Road has been passed onto enforcement and they are now following this up as Planning Permission is required. Also, an enforcement issue on Wall Lane Terrace where a business is being run from a garage is being followed up which was reported by the previous chair of our planning committee.
